As a self-regulating Association, the AATO's function is to:



In 1969 the Association of Architectural Technologists of Ontario (AATO) established its charter. For over four decades, AATO members have diligently served the building sciences community.

On December 19, 1996 the AATO realized fundamental change. On that date, an Act respecting the Association of Architectural Technologists of Ontario was established by the Ontario Legislature.

This Act recognizes the AATO's responsibility for the following titles:



- Architectural Technologists
- Architectural Technician
- Registered Building Technologist
- Registered Building Technician



MEMBERSHIP

Association of Architectural Technologists of Ontario is the only qualifying body in Ontario for Architectural Technologists, Architectural Technicians, Registered Building Technologists and Registered Building Technicians.

Primarily, accredited members have graduated from a recognized program of architectural or building technology, participated in a series of upgrading courses and lectures, fulfilled an internship work experience program and successfully completed a formal examination.

Persons who do not meet the minimum requirements must upgrade to the level of the architectural or building technology graduate, according to the Association's guidelines, prior to participating in the accreditation process

A member of the AATO is a qualified professional who holds public safety as paramount and seeks ongoing improvements to the construction industry. As professionals, each of our members is required to uphold our strict code of ethics, adhere to the requirements of the Association, engage in continuing professional development and ensure that the integrity of their profession is not compromised in any way.
